ALLEGATIONS

The Complaint Committee of the Minnesota Board of Accountancy ("Board") alleges as follows:

- 1. A complaint concerning Luis E. Del Moral ("Respondent") has been received, investigated and reviewed by the Board's Complaint Committee ("Committee").
- 2. Respondent does not currently hold a Certified Public Accountant ("CPA") Certificate nor has the Board ever issued a CPA Certificate to him.
- 3. The Committee has received information that Respondent twice used the designation "c.p.a." below his name on letterhead for L & M Tax Services, LLC in conjunction with a Minnesota business address.
- 4. Respondent's use of "c.p.a." below his name, as described above, is in violation of Minnesota Statutes Section 326A.10 (c), (d), and (e) (2010), as this abbreviation is similar to "CPA," is likely to be confused with "CPA," and tends to indicate that Respondent is a CPA.
 - 5. The following order is in the public interest.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, pursuant to Minnesota Statutes Section 326A.08, subdivision 4 (2010), that Respondent Luis E. Del Moral shall CEASE AND DESIST from using "c.p.a." in conjunction with his name and business, and from holding himself out to the public as a certified public accountant in any other

manner, whether in written, oral, electronic, or other communications; and from further violations of Minnesota Statutes Sections 326A.04 to 326A.11 (2010).

NOTICE OF RIGHT TO HEARINGS

Pursuant to Minnesota Statutes Section 326A.08, subdivision 4 (2010), Respondent may request a hearing in this matter. Such request must be in writing and served upon the Board within thirty (30) days after service of this Order, whereupon a hearing will be held within thirty (30) days after receipt of the request unless Respondent and the Complaint Committee agree that the hearing be scheduled after the thirty day period. In accordance Minnesota Statutes Section 326A.08, subdivision 4 (2010), if no hearing is requested by Respondent within thirty (30) days of service of this Order, this Order will become final and will remain in effect until it is modified or vacated by the Board.

In the event a hearing is scheduled in this matter, it will be held before an Administrative Law Judge of the Office of Administrative Hearings for the State of Minnesota, 600 North Robert Street, Saint Paul, Minnesota, telephone (651) 361-7900. All parties have the right to represent themselves or be represented throughout the proceedings herein by legal counsel or a person of their choice if not otherwise prohibited as the unauthorized practice of law. The hearing will be conducted pursuant to the contested case procedures as prescribed in Minnesota Statutes Sections 14.57-14.69, 214.10 and 326A.08, subdivision 4 (2010); Rules of the Board, Minnesota Rules Part 1105.5900 and Rules of the Office of Administrative Hearings, Minnesota Rules Part 1400.5100-1400.8500 (2011). A copy of these materials may be purchased from the Minnesota Book Store, 660 Olive Street, St. Paul, MN 55155, telephone (651) 297-3000, or are available at www.revisor.leg.state.mn.us. Copies of the rules are also available at www.oah.state.mn.us. They generally provide procedural rights of the parties, including rights to advance notice of witness and evidence, right to a prehearing conference, rights to present evidence and cross-examination, and right to purchase a transcript of the record. FAILURE TO ATTEND A HEARING OR PREHEARING CONFERENCE

IN THIS MATTER MAY RESULT IN THE ALLEGATIONS OF THIS ORDER BEING TAKEN AS TRUE AND THE PROCEEDING BEING DETERMINED AGAINST THE PARTY FAILING TO ATTEND.
