- 1. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2018).
- 2. The Board issued Paula Ann McKay a certified public accountant license on December 5, 1991.
- 3. Paula McKay's certified public accountant certificate expired on December 31, 2017.
- 4. On April 30, 2020, pursuant to Minn. Stat. § 326A.04, subd. 11, the Board revoked Paula McKay's certificate because she failed to renew it for more than two years after its expiration.
- 5. On June 26, 2020, Paula McKay petitioned to reinstate her revoked certificate pursuant to Minn. Stat. § 306A.09.
 - 6. This order is in the public interest.

IT IS HEREBY ORDERED, pursuant to Minn. Stat. §§ 326A.04, .09, that Paula McKay's inactive certified public accountant certificate shall be reinstated upon payment of \$195 in fees, consisting of a \$20 reinstatement application fee, a \$150 delinquency fee, and a \$25 renewal fee.

IT IS FURTHER ORDERED that if Paula McKay does not pay all required fees within 90 days, this order shall be automatically vacated, and Paula McKay's certificate shall not be reinstated.

IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Paula McKay's certified public accountant certificate and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2018).
