REINSTATEMENT ORDER

The Minnesota Board of Accountancy has determined as follows:

1. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2020).
2. The Board issued Respondent Sharyn Deans a certified public accountant certificate on July 20, 2001.
3. Sharyn Deans's certified public accountant certificate expired on December 31, 2006.
4. On April 21, 2009, pursuant to Minn. Stat. § 326A.04, subd. 11, the Board revoked Sharyn Deans's certificate because she failed to renew it for more than two years after its expiration.
5. On December 28, 2020, Sharyn Deans petitioned to reinstate her revoked certificate pursuant to Minn. Stat. § 326A.09.
6. This order is in the public interest.

IT IS HEREBY ORDERED, pursuant to Minn. Stat. §§ 326A.04, .09, that Sharyn Deans's inactive certified public accountant certificate shall be reinstated upon payment of \$775 in fees, consisting of a \$750 delinquency fee, and a \$25 renewal fee.

IT IS FURTHER ORDERED that if Sharyn Deans does not pay all required fees within 90 days, this order shall be automatically vacated, and Sharyn Deans's certificate shall not be reinstated.

IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Sharyn Deans's certified public accountant certificate and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2020).


