### **REINSTATEMENT ORDER**

The Minnesota Board of Accountancy has determined as follows:

1. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2020).

2. The Board issued Respondent Gina Sapia a certified public accountant certificate on May 14, 2010.

3. Gina Sapia's certified public accountant certificate expired on December 31, 2018.

4. On January 20, 2021, pursuant to Minn. Stat. § 326A.04, subd. 11, the Board revoked Gina Sapia's certificate because she failed to renew it for more than two years after its expiration.

5. On March 16, 2021, Gina Sapia petitioned to reinstate her revoked certificate pursuant to Minn. Stat. § 326A.09.

6. This order is in the public interest.

**IT IS HEREBY ORDERED**, pursuant to Minn. Stat. §§ 326A.04, .09, that Gina Sapia's active certified public accountant certificate shall be reinstated upon submission of satisfactory proof to the Board that she has completed 120 hours of continuing professional education and payment of \$250 in fees, consisting of a \$150 delinquency fee, and a \$100 renewal fee.

IT IS FURTHER ORDERED that if Gina Sapia does not submit satisfactory proof of completing the continuing-education hours and pay all required fees within 90 days, this order shall be automatically vacated, and Gina Sapia's certificate shall not be reinstated. IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Gina Sapia's certified public accountant certificate and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2020).
