**REINSTATEMENT ORDER**

The Minnesota Board of Accountancy has determined as follows:

7. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2020).

8. The Board issued Respondent Tina Kreidler a certified public accountant certificate on October 21, 2005.

9. Tina Kreidler's certified public accountant certificate expired on December 31, 2018.

10. On January 20, 2021, pursuant to Minn. Stat. § 326A.04, subd. 11, the Board revoked Tina Kreidler's certificate because she failed to renew it for more than two years after its expiration.

11. On September 16, 2021, Tina Kreidler petitioned to reinstate her revoked certificate pursuant to Minn. Stat. § 326A.09.

12. This order is in the public interest.


**IT IS HEREBY ORDERED**, pursuant to Minn. Stat. §§ 326A.04, .09, that Tina Kreidler's inactive certified public accountant certificate shall be reinstated upon payment of \$175 in fees, consisting of a \$150 delinquency fee, and a \$25 renewal fee.

IT IS FURTHER ORDERED that if Tina Kreidler does not pay all required fees within 90 days, this order shall be automatically vacated, and Tina Kreidler's certificate shall not be reinstated.

IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Tina Kreidler's certified public accountant certificate and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2020).
