**REINSTATEMENT ORDER**

The Minnesota Board of Accountancy has determined as follows:

1. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2020).
2. The Board issued Respondent Ethan Schmitt a certified public accountant certificate on September 15, 2014.
3. On April 9, 2018, Ethan Schmitt voluntarily surrendered his certified public accountant certificate.
4. On September 29, 2021, Ethan Schmitt petitioned to reinstate his revoked certificate pursuant to Minn. Stat. § 326A.09.
5. This order is in the public interest.

**IT IS HEREBY ORDERED**, pursuant to Minn. Stat. §§ 326A.04, .09, that Ethan Schmitt's active certified public accountant certificate shall be reinstated upon submission of satisfactory proof to the Board that he has completed 120 hours of continuing professional education and payment of \$150 in fees, consisting of a \$50 delinquency fee, and a \$100 renewal fee.

IT IS FURTHER ORDERED that if Ethan Schmitt does not submit satisfactory proof of completing the continuing-education hours and pay all required fees within 90 days, this order shall be automatically vacated, and Ethan Schmitt's certificate shall not be reinstated.

IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Ethan Schmitt's certified public accountant certificate and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2020).
